She previously cited disappointment with a board decision that prevented a Kwik Trip convenience store from being built in the Highway 33 corridor.

“I see a growing and thriving Saukville that follows in the footsteps of other Interstate corridor towns and villages, such as Grafton. Commerce that caters not only to those who live in the village, but that draw from all over the Ozaukee County area and beyond,” Kamenick said.

“Being able to attract new business and grow the community is difficult during even the best of times. We have to be open to businesses that will grow the tax base and help increase the quality of life of our residents.”

Krocka, 345 S. Colonial Pkwy., is seeking his sixth term on the board.

He said he takes great pride in serving the community as a trustee.

“I believe in this community, I have raised my family here and have committed the last 10 years to make sure we move forward in the right direction,” Krocka said.

“I have been on the board for the past 10 years and believe I bring knowledge and a firm commitment to help move our community in the right direction.”
